As Winter Months Quickly Approach...

Sec. 38-127. - Snow, ice, rubbish or other obstructions

No person having the care, either as owner or occupant of any house, building, or lot, shall fail to maintain the sidewalks adjoining the property in accordance with the following standards:

 Rubbish, including broken bottles and glass, filth, obstruction, or other nuisance shall be removed within 24 hours or as specified by chapter 14 of this Code if the provisions therein are applicable and require sooner removal.

- (b) Ice shall be removed within 12 hours after the same has formed or salt, sawdust, sand, or other abrasive shall be strewn thereon.
- (c) Snow that accumulates before noon on a sidewalk, as the result of a snowfall, shall be cleared from the sidewalk so as to afford reasonably unimpeded passage by the public by midnight of that date and any snow accumulating after noon on a sidewalk, as a result of a snowfall, shall be cleared to the same extent by midnight of the following day.
- (d) Snow that accumulates on a sidewalk as the result of plowing or drifting shall be cleared from the sidewalk so as to afford reasonably unimpeded passage by the public within 24 hours.

Hawk Nest East Lansing Public Schools

On November 11, 2013 the East Lansing Public Schools Board of Education transferred Hawk Nest Phase I and II students from Pinecrest Elementary to Whitehills Elementary starting next fall. Several Hawk Nest parents have voiced opposition to the switch. One concern is that switching Whitehills from a grade 5-6 school to a K-5 school may result in many teachers at Whitehills teaching outside their expertise. Parents questioned why 76 school of choice students would be allowed to stay at Pinecrest while 70 Hawk Nest students would be forced to attend Whitehills.

This action is the direct result of four school board members voting to close Red Cedar Elementary School, despite opposition from the City of East Lansing, MSU and many if not most East Lansing parents. Note that the driving distance is the same from Hawk Nest to both Pinecrest and Whitehills.

Elementary school students in Phase III, in the Lansing School District, have been able to attend East Lansing schools as school-of-choice students and ride the ELPS bus that stops in Hawk Nest. If Phase III elementary students want to ride the ELPS bus next fall they may now have to switch to Whitehills School.

Some Phase III residents have expressed surprise and concern that Phase III is in the Lansing School District, not the East Lansing School District. Other Phase III residents may like the fact the property tax millage rate is currently about 5.8 mills less in the Lansing School District. Michigan School Code allows 2/3 of Phase III property owners to petition the Ingham ISD to transfer Phase III into the East Lansing School District. The law also allows the Hawk Nest Board to initiate the request pursuant to a petition signed by 2/3 of the Phase III residents, once Hawk Nest is "completed".

November Neighborhood President's meeting

Mayor Nathan Triplett held his first meeting with the Council of Neighborhood Presidents Monday evening. City Attorney, Yeadon was there to speak on Deed Restrictions and Ordinances. Deed Restrictions are a private contract between the purchaser and seller. They are restrictions on the deed that place limitations on the use of the property. Generally, they established by the builder, and come with the purchase of the property. They usually can't be changed or removed

subsequent owners. Deed restrictions are put in place to maintain a desired look or character to the property and thereby maintain property values. It is the responsibility of the homeowner's association to enforce the deed restrictions of their neighborhood based on the provisions identified in the Master Deed and Amendments. According to Mr. Yeadon, "the City does not get involved in violations of deed restrictions unless it also violates a city ordinance." At the time of purchase of a newly constructed home, Mayberry Homes issues a copy of the Hawk Nest Condominium Purchaser Information Packet. This packet includes a Receipt and Instruction Master Sheet. Deed (Condominium Bylaws & Condominium Subdivision Plan). First. Second. and Third Amendments to the Master Deed, Incorporation, Articles of Association Bylaws, Disclosure Statement, and "The Condominium Buvers Handbook". These documents can also be found on website http://www.eastlansingneighborhoo ds.com/HawkNest . When selling your home, please pass the information packet to the new owner. If you purchased your home from a prior homeowner rather than a new construction from Mayberry Homes and did not receive an information packet, please contact the Hawk Nest Home Owners Association (contact information on this page).
